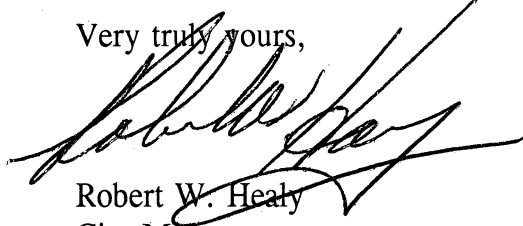

Subject: Council Order #13, dated 10/24/94 RE: Issue Regarding Mr. Barry Savenor of 72-74 Kirkland Street

In response to the subject Council Order, the pertinent facts are:

a. An anonymous complaint was received on Mr. Singanayagam's voice mail stating that a political sign on the property of 72-74 Kirkland Street was larger than allowed by the Zoning Ordinance (Section 7.16.12 limits political signs to 20 sq. ft.).

b. The complaint was investigated by Mr. Singanayagam and there was no sign evident. Therefore, it was determined that there was no cause for complaint.

c. I have not received a complaint concerning property at 72-74 Kirkland Street. The only complaint received by Mr. Singanayagam concerning property at 72-74 Kirkland Street was the anonymous complaint referred to above.

d. I notified both Mr. Savenor and Councillor Walsh of these facts.
