- WHEREAS: In April, 1983, a subcommittee of this City Council prepared a document entitled the Central Square Report which identified problems in the Central Square area and made recommendations designed to halt the Square's decline as a neighborhood shopping area; and
- WHEREAS: As a result of said report, the City Manager appointed the Central Square Committee to implement recommendations; and
- WHEREAS: To focus on the issue of economic revitalization, the Committee requested that a special Economic Development Subcommittee be established by the City Manager to develop an Action Plan for Central Square that is responsive to the resident, business and City's concerns for orderly economic growth of Central Square; and
- WHEREAS: This Subcommittee, after extensive deliberations and community meetings over the last two years has drafted an Action Plan which can serve as the effective basis for guiding the future development and use of this area; now therefore be it
- RESOLVED: That this City Council accept said Central Square Action Plan of the Economic Development Subcommittee as the general framework for growth, land-use and development in the Central Square Business District; and therefore be it
- ORDERED: That the City Manager refer this plan to the appropriate City Departments and agencies for implementation.
