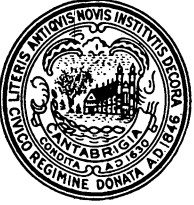

I hereby request an appropriation in the amount of \$223.49 to reimburse Daniel J. White, employee of the Public Works Department, for damages in this amount.

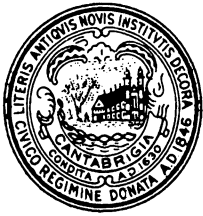
The Law Department, under the provisions of General Laws, Chapter 41, Section 100A, defended an action against Daniel J. White, in which there was a judgment of \$223.49.


