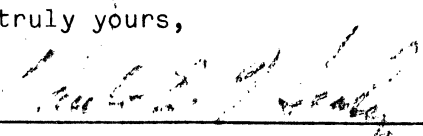

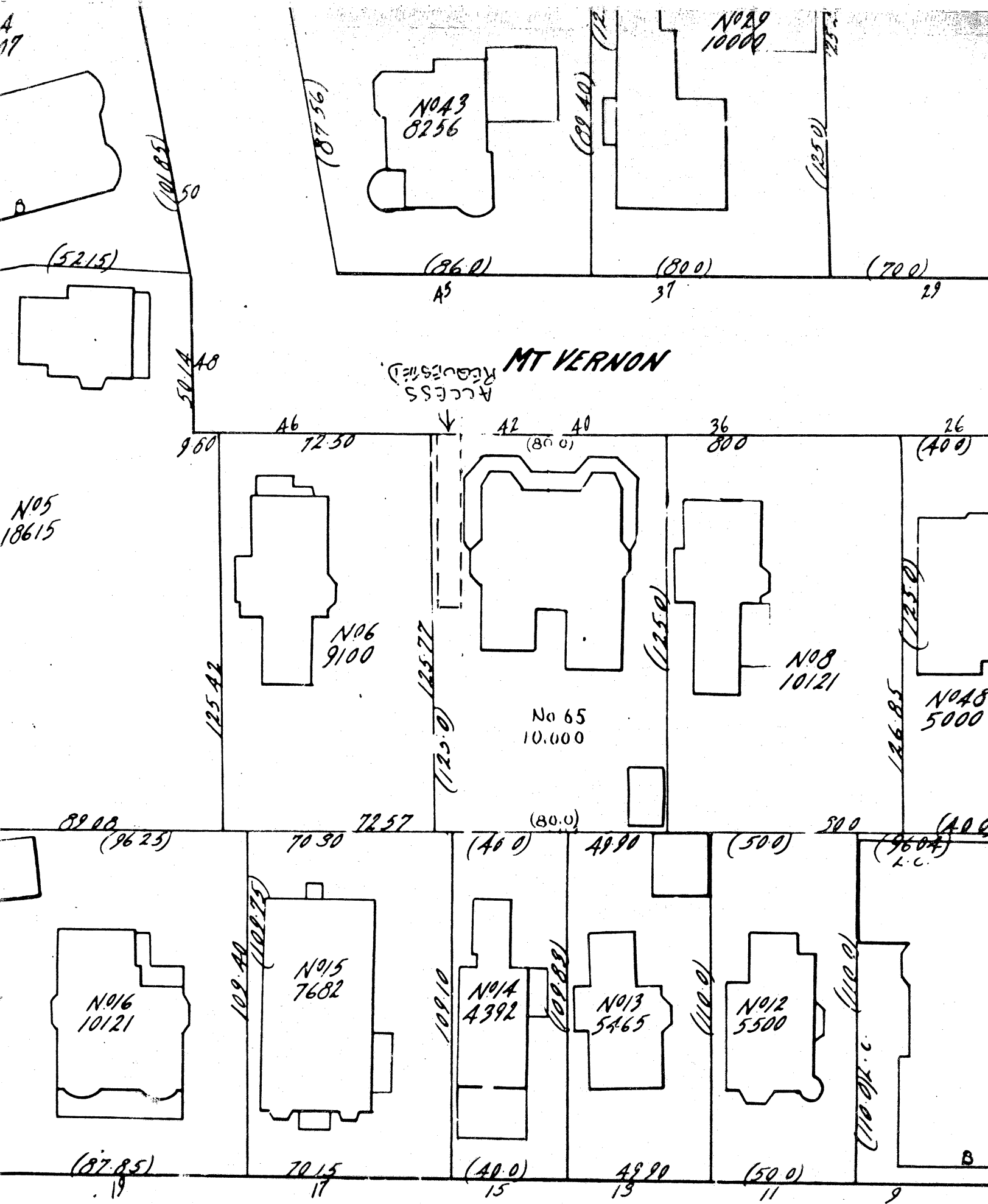

We have reviewed the proposed driveway at 42 Mt. Vernon Street. We have no objection to the curb opening but if vehicles are allowed to park in the driveways as shown on the attached sketch, there would be a violation of Article 6, Section 6.56 of the Cambridge Zoning Ordinance unless they have obtained a special permit from the Board of Zoning Appeal.

The undersigned respectfully pray that a driveway for residential use may be constructed and agrees to deposit with the City Treasurer the sum of seventy five (\$75.00) dollars, subject to the following conditions, to wit: In case the amount so deposited is in excess of the cost of the driveway, the difference shall be refunded by the City Treasurer, but in case the cost of the driveway exceeds that deposit, said deposit shall be applied as a credit to the bill and the balance shall be paid to the City Treasurer within thirty days from the receipt of the bill.
