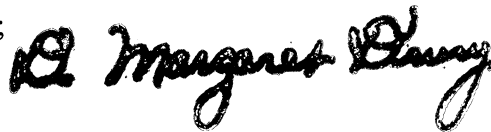

- WHEREAS: On December 5, 1976 Michael was elevated to Acting Lieutenant to Engine Company No. 8 and was promoted to Lieutenant on March 13, 1977; and
- WHEREAS: Michael was assigned to Fire Headquarters on April 9, 1978; to Ladder Company No. 2 on September 10, 1978; and
- WHEREAS: On January 24, 1982 Michael was elevated to Acting Captain for Ladder Company No. 2 and was promoted to Captain on May 9, 1982; and
- WHEREAS: Michael was assigned to Engine Company No. 6 on January 2, 1983; to Engine Company No. 9 on October 12, 1986; and
- WHEREAS: On March 1, 1988 Michael was elevated to Acting Deputy Chief Property Officer and was promoted to Deputy Chief on March 15, 1988; and
