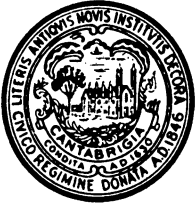

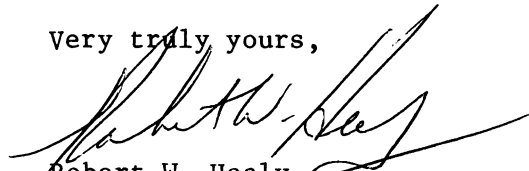
To the Honorable, the City Council:

Attached please find for your review and action an order requesting the acceptance and appropriation of a grant in the amount of \$130,000.00 from the Massachusetts Department of Education to the Department of Human Service Programs.
