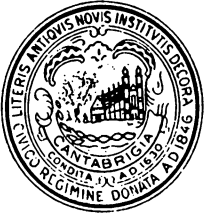

SUBJECT: Council Order #10, dated 4/8/91 Signage and enforcement
of dogs in Centanni Park

The enforcement directives for Centanni Park regarding dog waste will be as follows:

- * First, we will determine the times when the park is utilized the most, by dog owners. We will be arranging a meeting with the building superintendent from the buildings adjacent to the park to help determine these times. Once these times are determined we will direct our efforts to be present in the park at these intervals.
- * Second, Centanni Park will be listed as a target area. This means that during routine patrols in the area we will allocate specific times to be present in the park, in addition to the times determined earlier.

Furthermore, the Animal Control Department has initiated a scooper educational program. It started this year when the dog license applications were mailed to over 3000 residents. We also included a scooper informational sheet. Another part of this program will include various articles that will be printed in both the Chronicle and the TAB. The program will continue throughout the year.
