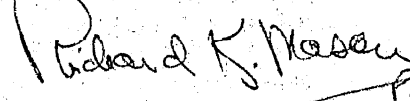

Dear Mr. Healy:

I have reviewed the Mobil Oil Corporation plans to rebuild its Service Station at Alewife Brook Parkway and Massachusetts Avenue. They are proposing to reduce the size of the existing driveways on Massachusetts Avenue by about 20 feet each, so that they would be 34 feet and 32 feet respectively. This will provide more defined access and egress and lessen the accident hazard.

I feel this permit should be approved, provided --

the driveway nearest Alewife Brook Parkway is an exit only.

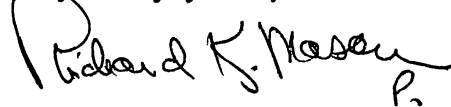
