IN CITY COUNCIL

October 30, 1978

ORDERED:

That in accordance with the provisions of Chapter 17, Article 1, Section 17-9 of the City Ordinance, the Commissioner of Public Works be and hereby is authorized to grant a permit to Carl F. Barron for the erection of a barricade four feet in front of the premises numbered 554-568 Massachusetts Avenue for the purpose of renovating windows in front of said building.

Provided that, before the erection of said barricade, the petitioner shall obtain a permit from the Building Department and file with the City Clerk a satisfactory bond in the sum of \$3,000 conditioned to save harmless the City of Cambridge from all damages arising from the erection and maintenance of said barricade.

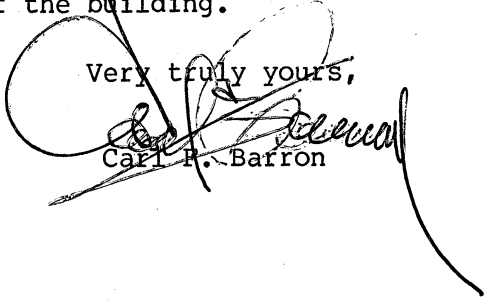

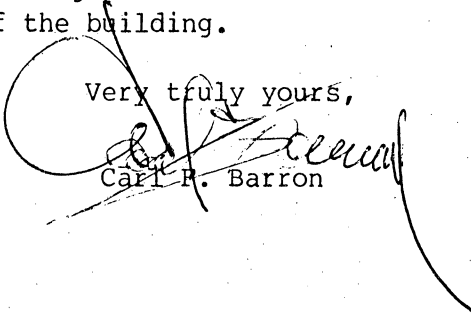
