- Middlesex Bus only takes from the City of Cambridge.
- Middlesex Bus does not give a discount to the elderly.
- Middlesex Bus does not stop at the Housing Projects or Senior Citizen Housing Units.
- Middlesex Bus only services people who have the ability to pay i.e. Hotel Customers.
- Middlesex Bus is not responsible to any authority in the City of Cambridge, such as, Cambridge City Council, Cambridge License Commission, or the Hackney Bureau.
- Middlesex Bus' drivers are not scrutinized by Cambridge Licence Commission and Police Dept. as the Taxi Driver is.
