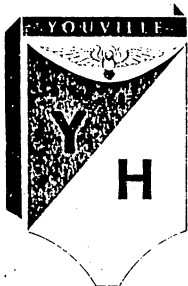

Dear Mr. Sullivan,

I understand from newspaper accounts that the City plans to acquire the Youville Hospital property located on the west side of Hovey Avenue for off-street parking purposes. Before any action is consummated, I hope you will extend to me the opportunity to discuss our plans relative to the Hospital's expansion program necessary to fill the health needs of our community.

As you may know, in 1894 the Grey Nuns were invited by Father Thomas A. Scully, Pastor of St. Mary's Church, to establish a hospital on this location to serve a unique type of patient. We have done this to the best of our ability. During those years, we have not only cared for many members of this community but we have also made employment available for many others living in our neighborhood. Through long-range planning, it has taken the Hospital years, as well as great economic sacrifice, to acquire the present land area.

We have especially enjoyed the wonderful relationship we have shared with the City of Cambridge and it is our wish that this may continue.

While we recognize the needs relative to the High School project, we feel a particular responsibility to those persons we are committed to serve.

I should like to request the opportunity to meet with you at your earliest convenience for the purpose of discussing this matter further.
