To the Attention of the Town Clerk:

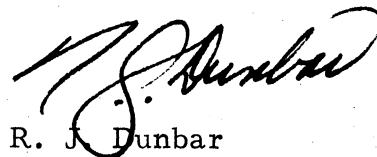
