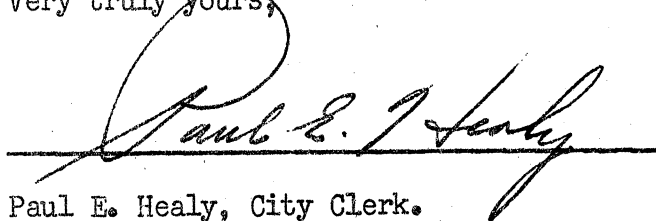
Enclosed herewith you will find the petition of Lucy Mackall,

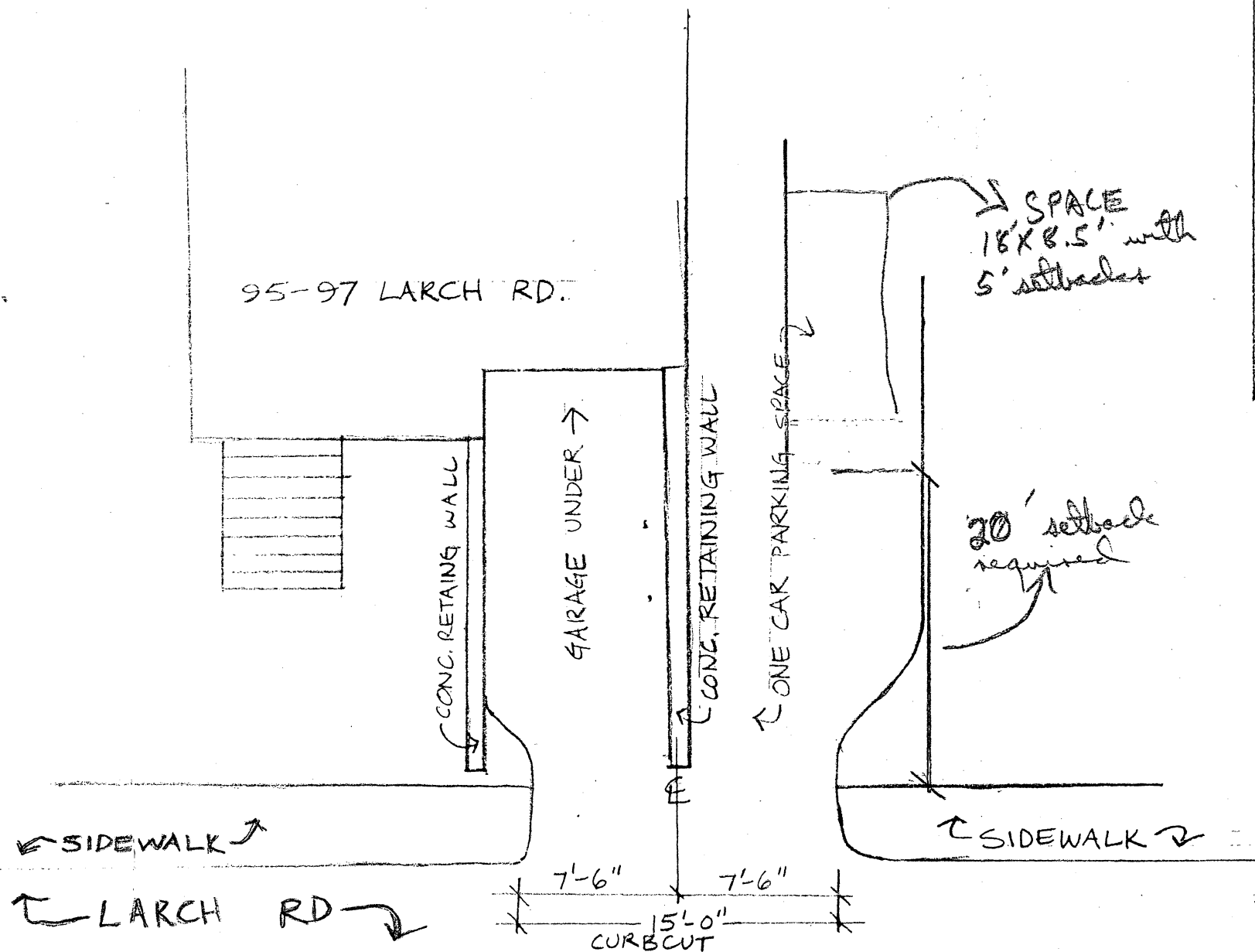
