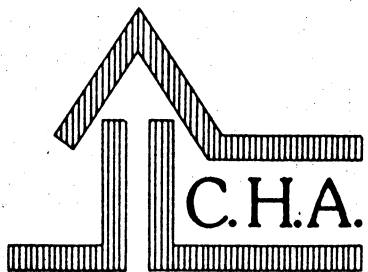

Dear Cambridge Community Leader:

Every 18 months the Cambridge Housing Authority creates a new waiting list for public housing. The October 1986 waiting list for Cambridge Public Housing is coming to a close on April 22, 1988.

This notice is to inform you that the CHA will be accepting applications for the new public housing wait list beginning April 11 through April 22. To be considered for public housing for the next 18 months, all applicants must complete a new application.

To be eligible for public housing, the gross family income must not exceed the following limits:

Please make every effort to inform eligible families of this rare opportunity. Remember, it is an opportunity that is only available to them once every 18 months.
