TO: G-4 MOTOR VEHICLES\$35,000.00

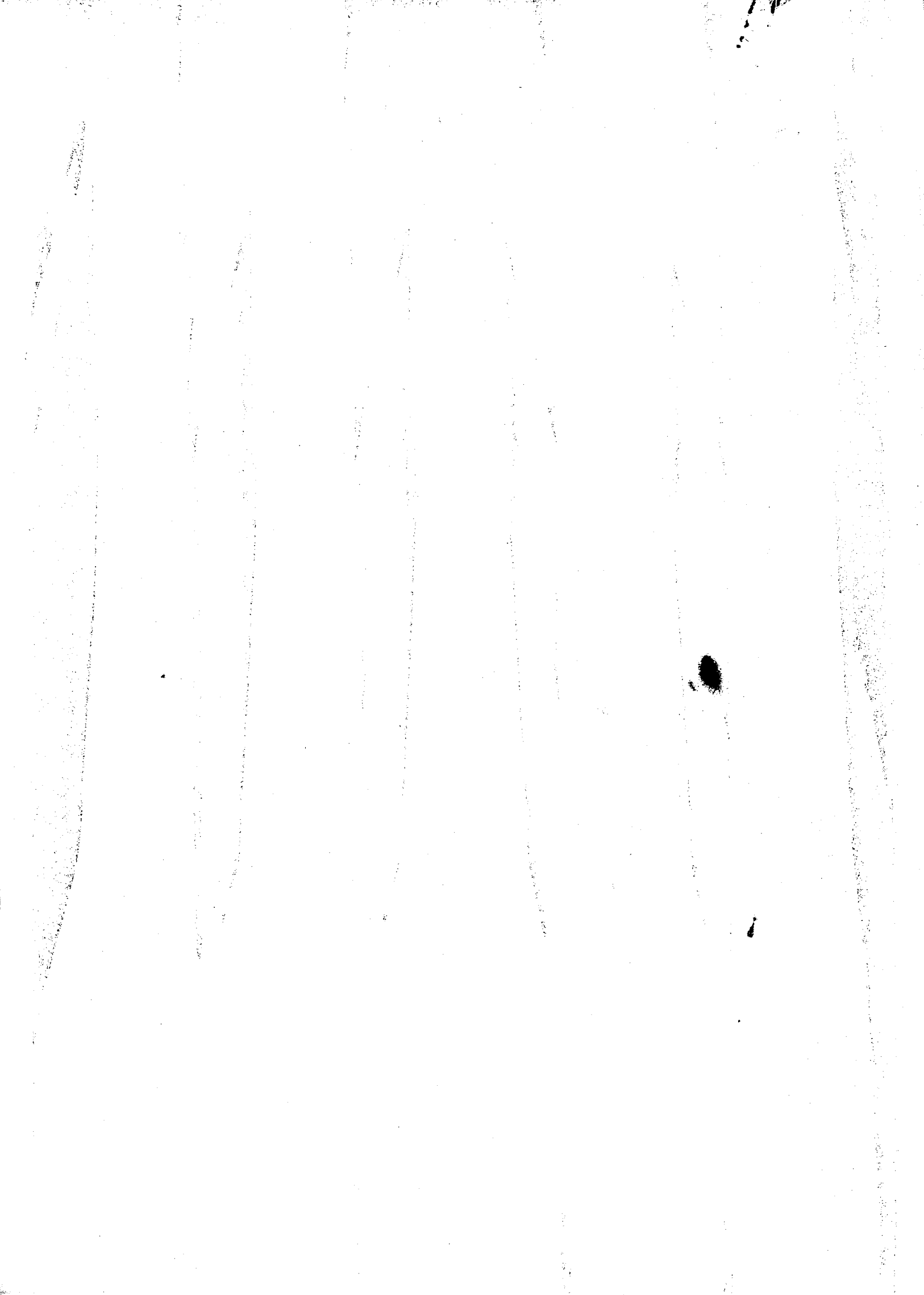

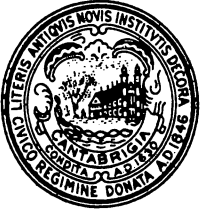


