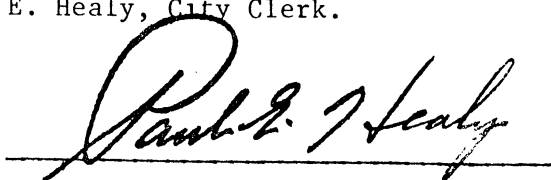

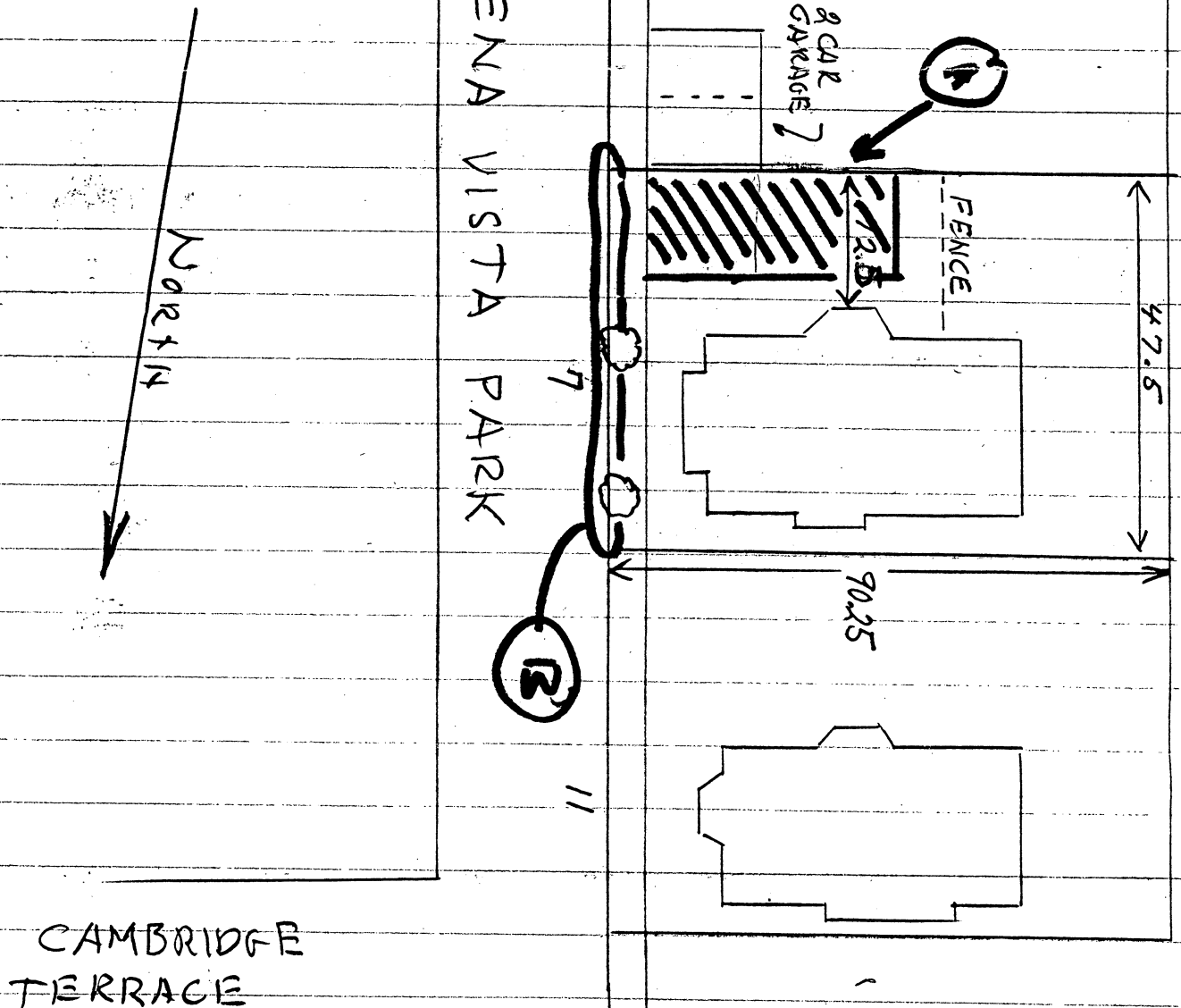
Enclosed you will find two drawings labelled drawing I + drawing II which ought to help you in passing on my petition for a driveway at my residence.

Drawing I provides an overview; it locates the desired driveway, (reference A), within my house lot and orients the house lot in relationship to nearby streets. Drawing II provides a closer view of the desired driveway within the house lot. It also includes a description of the present curbage (REFERENCE B). Notice in particular that two sections of curb are missing including 4' 8" section (REFERENCE B1) that straddles the property line between my property and the property to the south, 127, 131 Upland Road, and a 5' 3" section (REFERENCE B2) that was evidently removed years ago for reasons not known to me. Construction of the driveway would require the removal of approximately 8' (eight feet) of curb as indicated on drawing II.
