Unfortunately, because of its peculiar 1938 charter, the "Peoples Republic" of Cambridge does not follow the model of other democratic federal, state – or even other local governments. Thus, in Cambridge, an unelected City Manager, who is not directly accountable to the voters, has the power to make appointments which affect our lives and the future of Cambridge. Cambridge's City Council is even precluded from an "*advise and consent*" role by criminal penalty. (see discussion about §107, above). Appointments to boards and commissions should clearly and properly be the job of elected officials such as City Council.

- *On the one hand*, many in Cambridge agree that the City Manager has worked diligently on financial management for the City of Cambridge. For example, the City has money in the bank and a good bond rating. The garbage is picked up, and the streets are swept.
- *On the other hand*, a review of commissions and boards appointed by the City Manager shows that approximately half the appointments have expired without new appointments. Some appointments expired more than a decade ago.
- Further, although we have more than 90,000 talented people in Cambridge, the same names repeatedly show up on the commissions and boards, to the exclusion of numerous other Cambridge residents who want to participate in government.

Clearly, the City Manager has concentrated on what he feels he does best, working on financial management for the City, to the neglect of keeping commissions and boards current.

Transferring authority to making appointments to boards and commissions to City Council will provide the tools to City Council to do their job, as well as electoral accountability, without affecting the City Manager's financial management.

This Charter statute, MGL c. 43 § 104, enacted by the legislature, can readily be amended by the legislature to be fairer to the Cambridge City Council. For example, a home rule petition sponsored by Cambridge's four state representatives and three senators, could surely be brought to bear to better empower Cambridge's own City Council, by changing this outmoded statute.

Therefore, I respectfully propose we open a dialogue on all sides in the City of Cambridge to review this draconian, 58-year old charter, to sponsor new remedial legislation to empower the City Council, provide for appointments to boards and commissions by the Council, and give the Council the tools to get the job done which they were elected to do.

**Charter Reform to Enhance City Council and Voter Powers
With Council Appointment of Boards and Commissions:**

Cambridge's out-of-date, 58-year old Plan E charter, punitively restricts the powers of the City Council, and needs to be revised.

Last week I noted how the Charter criminalizes normal and reasonable behavior by City Councillors, such as giving job referrals to Cambridge residents. Innocent behavior such as that can give Councillors fines, imprisonment, and restrictions against ever holding office in the city again. This is absurd: we treat our City Councillors worse than convicted bank robbers and drug dealers. That statute, MGL 43 §107, needs to be deleted or substantially modified. (see annexed).

A further problem with Cambridge's charter is that it seriously and improperly limits the power and authority of the City Council. Cambridge citizens elect City Council to do a job, but don't realize that we're not giving City Council the tools to get the job done. Because of these draconian and obsolete Charter statutes, which apply almost solely to Cambridge, we set City Council up for repeated frustration and failure.

For example, week after week, Cambridge residents come to City Council to complain about the operations of some board or commission. However, frustrated some City Councillors may also be, because of the obsolete Charter, there is often little City Council can do. It is the City Manager, not the Council, who appoints most boards and commissions. Thus, because of the wording of the Charter statute, City Council takes the public blame for appointments made, and power exercised, by someone else.

Under this Plan E form of government, the unelected City Manager derives appointment power for boards and commissions from only one sentence:

"He [the city manager] shall make all appointments and removals in the departments, commissions, boards and offices of the city for whose administration he is responsible, except as otherwise provided in this chapter." See MGL c. 43 §104, annexed.

By comparison, in federal, state, and other municipal governments, the elected executive officer, president, governor, mayor or city council makes appointments. Generally, these appointments constitutionally have to be approved by congress, the legislature, an elected governors council, or the like. In most other Massachusetts cities and towns, boards and commissions are appointed by an elected mayor or city council – or else people are elected directly to boards and commissions by the voters.
