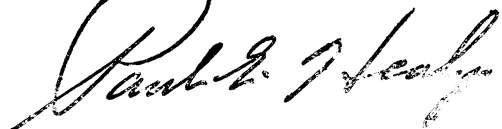

To the Honorable, the City Council:

Attached please find for your review and action an order requesting the acceptance and appropriation of a grant from the Massachusetts Department of Mental Health in the amount of \$750,000.00 to the Health and Hospital grant fund. This appropriation should be budgeted in Salaries and Wages (\$427,443.00) and Other Ordinary Maintenance (\$322,557.00). This grant award will be used for the training of Psychiatry residents at the Cambridge Hospital, overseen directly by the Department of Psychiatry.

This appropriation will fund 9.6 months of the FY86 Psychiatry resident training program. A subsequent appropriation request will be made for the remaining 24 months when the State budget is finalized.

Passage of this order is recommended.
