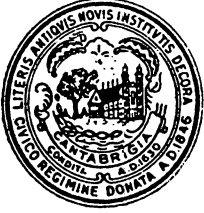

In amendment to an ordinance designated as the "Cambridge Municipal Code"

Section 12.16.170 (Street performers) is hereby amended by adding the following sentence to subsection E.2:

"No performer or group of performers shall remain in a location for longer than two hours".
