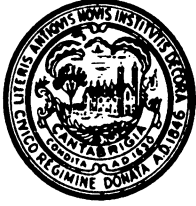

To The Honorable, The City Council:

I am hereby requesting the appropriation of \$63,000.00 in the Grant Fund of the Department of Human Services Salary and Wages Account (\$54,539.00), Other Ordinary Maintenance Account (\$7,461.00) and Travel and Training Account (\$600.00) from the Massachusetts Department of Public Health's Tobacco Control Program. These funds will be used by the Department to build and support a City-wide coalition working on tobacco related issues. The funds will be used to pay salaries, wages, general operating expenses of the grant and required travel expenses. The funding is derived from the Commonwealth's tax on cigarettes.
