As you may know, the Friends of Cambridge Athletics is a newly-formed, city-wide, grassroots organization dedicated to the following principles:

- focus on fundraising for new program development
- provide assistance to develop booster clubs to support individual teams
- sponsor recognition activities for student athletes
- foster student/athlete civic participation

At our November 3, 1997 meeting, the Friends of Cambridge Athletics, in response to a citizen petition, voted unanimously to pass the following resolution:

“Whereas the Friends of Cambridge Athletics is a community organization concerned to enhance the highest quality of athletic programs for all youth of Cambridge,

And

Whereas the Friends of Cambridge Athletics heartily endorse and support the commitment of the Cambridge City Council and the Cambridge City Manager to develop better athletic facilities for all youth of Cambridge, the Friends of Cambridge Athletics hereby requests the Cambridge City Council to direct the City Manager to:

- 1.) Allocate the monies that he has recommended in the current capital budget towards the creation of a state-of-the-art facility for Cambridge football and track programs, and,
- 2.) Appoint a representative site selection committee for the purpose of implementing the creation of this multi-use facility.”
