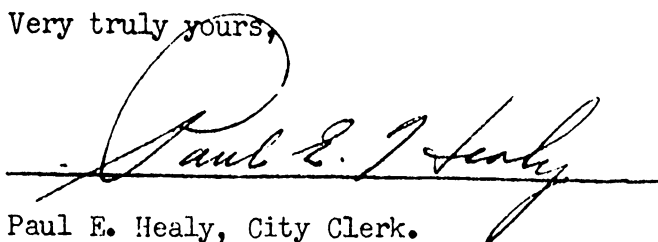
Dear Neighborhood Representative:
