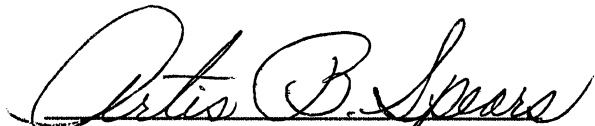

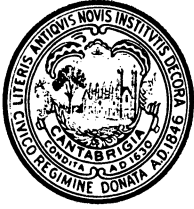

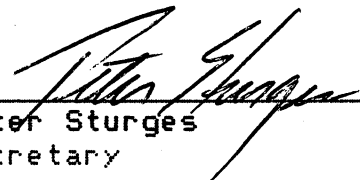
At a regularly scheduled meeting of the Board of Election Commissioners, after the redistribution of Mayor Leonard J. Russell's ballots had been completed in accordance with the law and notice duly given to all candidates and elected city officials, it was moved, seconded, and

VOTED: that all city council candidates, defeated in the November, 1983 Municipal Election, are hereby declared to be eligible, based upon an examination of the public records maintained by the Election Commission, to fill the vacancy that occurred on the Cambridge City Council on Sunday, June 16, 1985.

VOTED: that Alfred W. LaRosa having received 847 out of a total of 2899 votes is hereby declared elected to the Cambridge City Council to fill Mayor Leonard J. Russell's seat for the remainder of Mayor Russell's term.

VOTED: that the City Clerk be notified of the votes taken by the Board of Election Commissioners on July 2, 1985 and the official results of the July 2, 1985 redistribution of Mayor Russell's ballots.
