We hope to have approximately ten minutes of your time to discuss the plans that are in progress and look forward to meeting with you at this time.

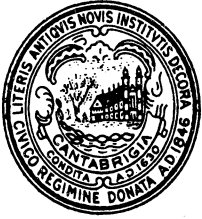
