Your kind attention in this matter will be greatly appreciated.

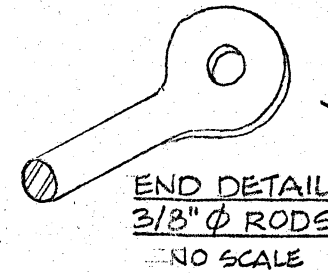
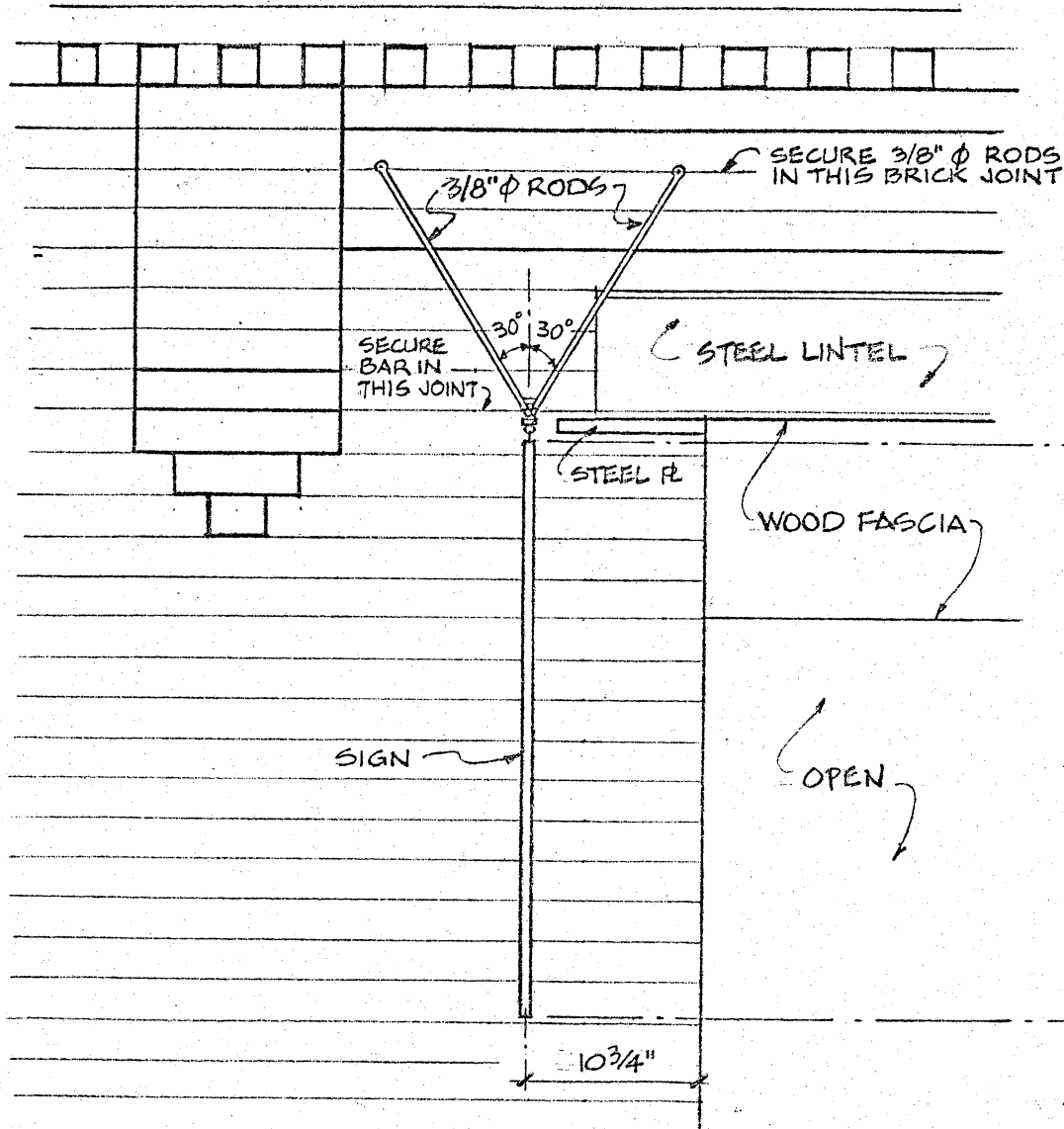

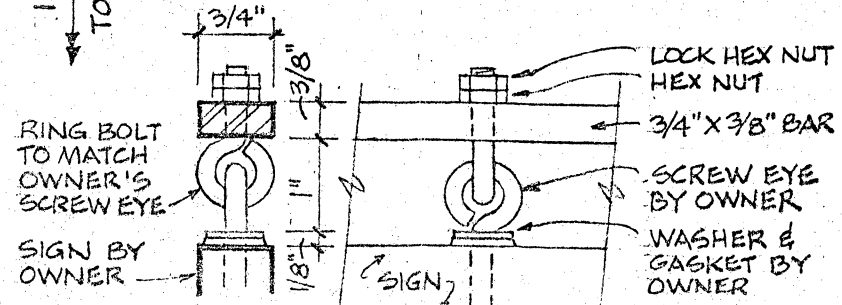
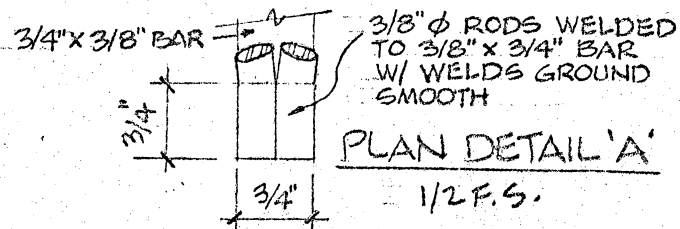
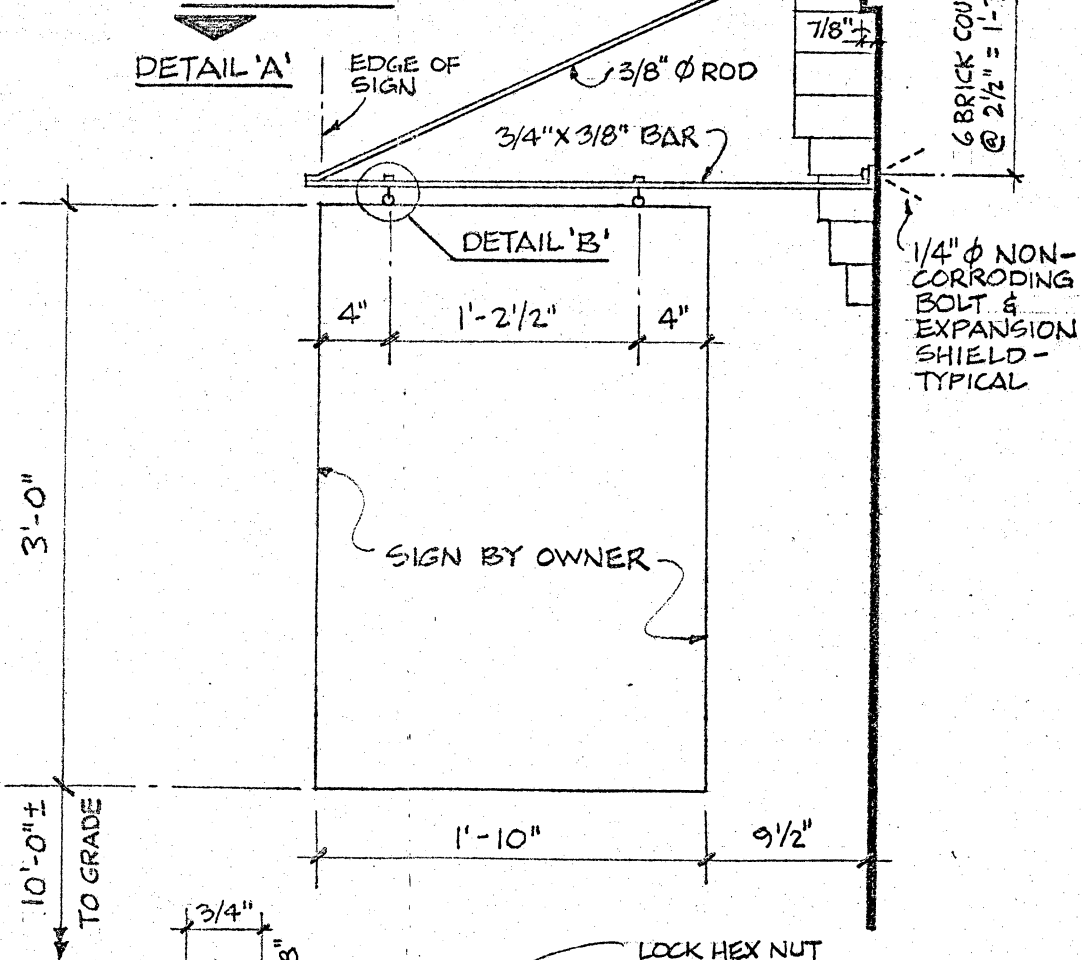
SIGN FOR BOW & ARROW STOVE CO.
