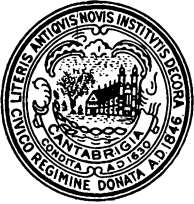


Dear Sir:

I hereby request an appropriation in the amount of \$200.00 to reimburse Robert J. Klooner, an employee of the Police Department for damages in this amount.

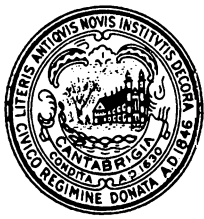
The Law Department, under the provisions of General Laws, Chapter 41, Section 100-A, defended an action against Robert J. Klooner in which there was a judgment of \$200.
