
Dear Sir:

I hereby request an appropriation in the amount of \$500 to reimburse Frank Wright, an employee of the Public Works Department for damages in this amount.

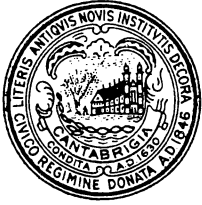
The Law Department, under the provisions of General Laws, Chapter 41, Section 100-A, defended an action against Frank Wright in which there was a judgment of \$500.


To the Honorable, the City Council:
