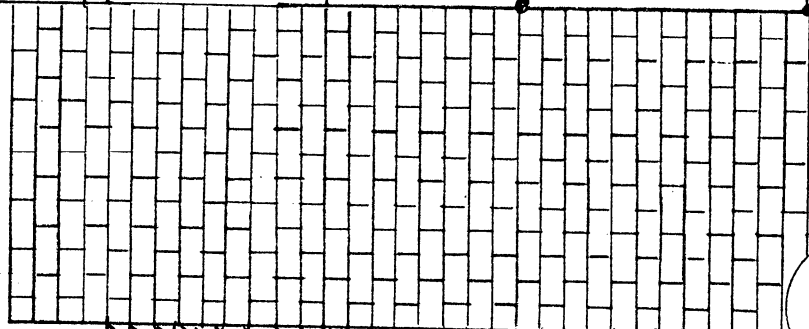


Concrete Walk
