I hereby request an appropriation in the amount of \$73.54 to reimburse Marnetto Lampedecchio, employee of the Public Works Department, for damages in this amount.

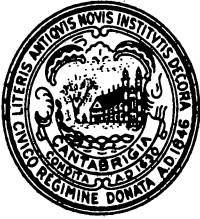
