from Magazine st.
 - 1 Chestnut Tree, at 25 Pleasant street.
 - 1 Elm Tree, on Main street westerly side near junction with
Mount Auburn street.
 - 1 Linden Tree, on Beal street southerly side, East of, and
near Mercer Circle.
 - 1 Apple Tree, on Mount Auburn st. southerly side,
at Hospital fence.
 - 1 Linden Tree, on Mount Auburn st at McDonald's gateway.
 - 1 Linden Tree, on Garden street S. side near gateway to old
Armed grounds.
 - 1 Elm Tree, opposite 86 Hancock street,
 - 1 Tree, on Hancock street opposite Centre street.
 - 1 Elm Tree, on East side of Hancock st. opp. Chatham st.
 - 1 Elm Tree, opp. 457 Cambridge street,
 - 1 Elm Tree, corner Cambridge and Elm street.
 - 1 Elm Tree, Otis street, opposite School-house.
 - 1 Linden Tree, School street, north side, east of, and near
Grindstone.
 - 1 Tree, opposite 158, Putnam avenue, 2^d Tree from Pleasant st.
 - 1 Tree ~ ~ 106 Braigie street,
 - 2 Trees ~ ~ 85 Brookline street,
 - 1 Tree ~ ~ 721 Main street,
 - 1 Tree ~ ~ 44 Broadway.
