To the Honorable, the City Council:

In June of 1971, your Honorable Body voted to submit an application to the U. S. Department of Housing and Urban Development for receipt of a Neighborhood Facilities grant to rehabilitate the Cambridge Community Center at 5 Callendar Street. The City agreed to submit the application on behalf of the Community Center because only public bodies are eligible to apply for and receive money under the Neighborhood Facilities Program.

The understanding was clear from the start, however, that no City money would be contributed to the project. Any funds needed over and above the HUD grant would have to come from the Center or other outside sources.

As you are undoubtedly aware, the renovations are currently under way at the Center and the project is moving along well with construction expected to be completed by next month. The Cambridge Community Center has contributed \$7,179.00 toward project costs and it is respectfully requested that your Honorable Body accept this gift which, in turn, will be transferred to the Capital Improvements account to be used for payment of the invoices for this project.

Attached herewith please find appropriate order of acceptance and transfer of funds to the Capital Improvements account.
