
Dear Sir:-

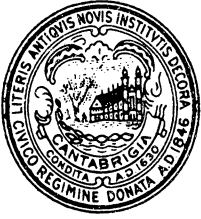
As you can appreciate this is a "Cambridge First" and an appropriate F-7 account should be set up in the Annual Budget of the City Council for the year 1972.


