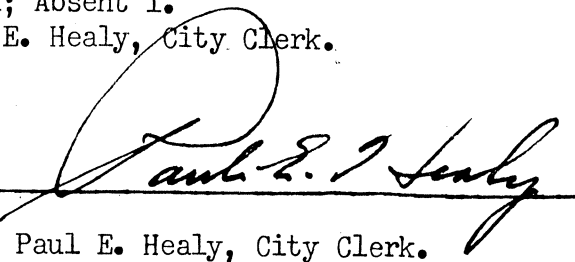

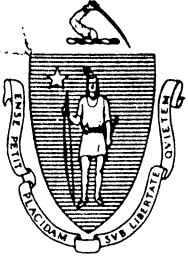

IN THE YEAR ONE THOUSAND NINE HUNDRED AND EIGHTY-ONE.

AN ACT RELATING TO THE FEES FOR LICENSES AUTHORIZING THE SALE OF ALCOHOLIC BEVERAGES IN THE CITY OF CAMBRIDGE

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

SECTION 1. Notwithstanding the provisions of section seventy of chapter one hundred thirty-eight of the General Laws, as last amended by section fifteen of chapter nine hundred twenty-nine of the Acts of 1977, the fee for a renewal license or permit under said chapter one hundred thirty-eight granted by the Cambridge License Commission may be paid into the treasury of the City of Cambridge semiannually.

To the Honorable Senate and House of Representatives of The Commonwealth of Massachusetts
in General Court assembled.

The undersigned, citizens of Cambridge respectfully
petition for the passage of the accompanying bill or resolve, and/or for legislation relating to the
fees for licenses authorizing the sale of alcoholic beverages in the
City of Cambridge.
