A Foundational Plan
for the creation
of An American
Everlasting Constitution

Let This Work be dedicated in The Name of The Source of Life
Unfathomable, Perfection Imperceptible , Love Beyond the Imagined

This document sets the groundwork, smooths over obstacles on the path presents a concept, shows a way for a format upon which 263,000,000 people may join together at common junctures of interest to create an Everlasting Constitution.

The Everlasting Constitution will be written because The People of United States of America are a Great People who Deserve and Desire and are Worthy of a more Perfect and Beautiful Form of Self Governing Unity.

America is filled with People of Great Ability and Wondrous Aspirations. The Past mentalities of authority no longer fit the ingenious wisdom The People are capable of and are ready to pour into Our Everlasting Constitution. Let The Mighty Rivers of Expression Flow.

Why is a constitution needed ? In order for people to carry out life's basic activities, so that societal coordination may exist, people have need of seeing a BASIC ACTIVITY ARRANGEMENT PLAN UPON WHICH THEY CAN CHOOSE OR NOT CHOOSE TO COME TOGETHER AND BE.

Once people agree on a basic plan, richer and more complex activities can be carried on because the people can depend the plan's guidelines for basic cooperation.

This basic agreement or format of life coordination is called
A Constitution.

As in all things the full range of possibilities exist. There can be constitutions that are failures, mediocre (meaning things don't work really enjoyably well) or more successful but for the benefit of some rather than everyone.

In preparation for smooth sailing there is a need to iron out stumbling blocks that unless clearly defined at the very beginning, could have the potential to cause great confusion, impatience and stagnating delay.

Those potential stumbling blocks areas were, (1) How do we coordinate the elements of our nation who are oppositional to one another (2)The reason why The Declaration of Independence IS part of The Constitution, (3)The proof within the Constitution that it does provide protection against unfair taxation. (4)A way to understand how to control the Military Budget because without such, endless reasons could arise to spend uncontrolled amounts of money. This vulnerability would only drain the nation's strength and leave open a broken faucet of corruption.(5) And the idea of achieving a healthier concept of the use of money.

An Everlasting Constitution would be the Strongest of constitutions. Therefore it would cover difficult matters. It would include finely tuned instructions for different variations of situations, so there could be no vulnerable weakness for the penetration of societal confusion, enemy covert or overt overthrow or degenerative societal dullness in operations.

All words in it that could possibly misunderstood or misinterpreted would, within it, have their meaning CLEARLY DEFINED.

Where shall we begin ? We shall begin where we want to end up. Where do we want to end up ?

We want to be Strong. The first prerequisite of strength is information about our total situation. We want continual access to information about our total circumstances.

We want to experience life in a Rich way. The universal meaning of Rich is enjoyment. We want to enjoy all aspects of our life activities. Now of course we enjoy life in different ways. But here we are referring to a common ground of enjoyment. If it isn't, there's something wrong. A Rich way helps to make life Fun, enjoyability energizes people to be Strong.

Rich also means being able to experience life in a full way. For example the opposite of experiencing life in a full way would be to live in a world weak when confronting anything different than its way. Where as living in a world where there is a rich opportunity for experiencing difference prepares us for interacting with situations that are different. Therefore we should allow and protect difference so long as it can connect with the common ground of basic societal cohesive needs. For us to be the strongest we can, our standard should be taken from the Ultimate Standard which is the example The Universe sets.

The Universe vigorously encourages and maintains Numberless Varieties of different species. And therefore to believe that a species other than ours or a style other than ours shouldn't exist would be the height of foolishness, misunderstanding and weakness.

So our challenge is to produce a core of guidelines that enables us to relate to and come together when national and planetary unity demand for our mutual continuation.

But even though a key goal is fun, let it not be believed that in the end it is society's or the government's responsibility to make the individual happy, Other than happy in the way they procedurally interact with and respect the individual's basic rights.

The only people who are truly part of a nation are those who participate in its security and well being.

Going along for the ride, contributing money now and then and mouthing ritualistic national themes are not the ways of those who meaningfully participate in a nation's vital well being.

Nor can anyone make those who don't have the inspirational understanding of why caring for a nation is important, care about maintaining the nation.

So my words and care and actions are not meant for the lazy, the selfish, the unintelligent. By unintelligent I do not mean restriction to an elite group of thinkers. By unintelligent I refer to those who do not even have the common sense to know that life has many facets and that the potential for the need of patient thought has to be respected and considered in figuring out good ways of doing things. If just that level of common sense isn't present how can the level of dependable intelligence required for creating and maintaining a nation be achieved ?

I speak only to those who know that Life is a wonderful mysterious phenomena to be experienced vigorously by the powerful, the creative, and those who find enjoyment in continually learning and perfecting its ways and actions. If that scares you, then what kind of a nation do you belong to ?

Because Life will always contain everything there will always be cruel vicious forces who will totally be dedicated to doing whatever they can to live by taking from and oppressing others. Their love will be that of gathering servants, slaves and robot minded destroyers into organizations which take and cause harm to others.

And so those, whose love it is just to enjoy the fullness that life naturally provides without causing harm to others, must be prepared to deal with this challenge by creating great organizations which possess all the fine powers necessary to playfully direct the demented expansions of the oppressors so that they only expand into their own and their unwitting victim's elimination. For all those who deny the existence of the forces of premeditated violence will one fine day meet up with reality.

The weak, the fearful, the fools who only want to play, those who only just want to live their private lives in peace, the lazy, the disrespectors of intelligence, do not survive.

So with these thoughts we see the real purpose of a nation and what a nation is. It is a system which enables its citizens to sustain their existence against the forces of negative destruction, chaos, despair, poverty, war and catastrophe. To participate in the ways of a great nation is the line which defines those who are only capable of living within the philosophy of mediocrity, those are just satisfied with muddling along from those who love The Victory of Living Life to its Great Potentials.

This is truth. Truth will always be rejected by those unwilling to bear it and treasured by those who are fascinated with its invigorating chill.

Our Everlasting Constitution Must Be Applied to the Reality of our present situation. Which means we must look at America AS IT PRESENTLY IS. We must face the problems and come up with solutions that solve things head on. We are dealing with deep emotions and therefore must work gently to loosen up the tensions and give birth to getting people to realize that there are ways of doing things in a better way.

Only those who agree to live and let live can be part of the process. If you truly have faith in who you are and what you believe in, it will hold up when interacting with different points of view as long as you and others allow each other, a decent space. The Universe is a Big Place. Holding and relating to that bigness and depth inside of you will create it in your physical environment.

In America what we have at this moment is basically a nation filled with many different points of view as to how things should be done. Therefore the question becomes how do we get these different points of view to agree upon a common ground whereby in the end each gets to live the way they would like? The answer is provided in the last sentence.

Only those who have the common sense that just as we all See by the same same light, so to there is a common sense common ground whereby each can live and let live. Only those capable of the awareness that we all have the same common basic concerns will be able to make it happen. All others will be left to live their empty chaotic lives. You'll know those who are not part of the process when they stand up to declare that others have no rights. They will be the problem and must be managed so that they are forced to let others be.

But consider for a moment, even those who extremely disagree with each other or even hate each other may be capable of respecting each other's space. If just that amount of actual reality is possible, participation is welcome.

To give a deeper reason for why participation be extended to hostile parties, requires a twofold answer.

For the existence of conflicting parties would seem to indicate profound disunity. And viewed from a simple materialistic level that would be correct.

But looked at from the greater spiritual level the disharmonious parties become aspects of a mysterious arrangement wherein something greater and finer may be formulated if the attributes of careful examination, wise strength and patient development are applied. There is treasure to be found in dealing with difficulty. For just as every single thing you see has two sides, hostility must contain its opposite side. The power and treasures gained from making it to the other side may be worth much more than expected.

The second reason is unusual but factual. The ultimate destiny of any planet's species, if they survive that long, is to interface with what is beyond their planet. With what they will interface with among the COSMOS. A healthy society should always be preparing for the Ultimate Infinite and endlessly changing encounter. A Source so loving and Vast that we cannot easily comprehend it, especially when it appears to us in a mode which we are not in harmony with. It is by understanding this unity of Source that we experience the magic of Difference meeting in unity. For example shall we allow an economic format which permits some to make vast amounts of money in such a way so that it causes others to those their homes or places to live ? Is this why we have joined together ? To live dog eat dog lives ?

We are talking here about expanding our life organizational vision with much more depth and interesting ways, not only highly serious matters. There are other areas less serious but as important because all basic matters are edges influencing either directly or indirectly how the ship's overall well being is influenced and sustained. We have to have ways in which we see, well in advance, before things go extremely off track, that harmful situations are developing.

One specific guideline would be the protection of "No Harm" legislation. For example in the areas of natural healing substances, that when taken cause "no harm" or therapies which require no surgery or unnatural substances. Right now there is legislation trying to prevent such healing therapies from being legal. The cause of this is, so expensive secondary manufactured processes can corner the market. So here we see an instance where the scale is tilting from ethical fairness into greed. Here "No Harm" legislation would insure the security of direct pure healing methods. More in harmony with keeping our natural resources secure. Why should areas of action which cause no harm be legislated against ?

Then there are areas of lifestyle which have never been taken seriously. Yet when it comes to the actual enjoying of life, these areas must be respected as part of our overall fine tuning.. Such as realizing that Freedom of Religion means non interference with marriage decisions. All religions incorporate within their framework guidelines for marriage. Marriage is part of the religious process. When there are consenting partners, there is no harm. The truth is if you believe that what you believe is the ultimate you will be secure no matter what others do so long as others respect your basic rights.

Another seeming lesser example no-harm-area but a never the less meaningful aspect of life style is the subject of no pets in restaurants. All over the world people go home to dinner with pets present and all parties involved live long lives. Yet society makes a general rule that there can be no restaurants where pets are present. Here we have a particular "No harm" area. Definitely there are people who are allergic to animals and there should always be the choice of restaurants or cafés which restrict animals. But there should also be restaurants which allow animals at least in the customer areas. Fine tuning. WE must analyze these lifestyle issues so we can truly enjoy our lives by ending the endless friction caused by these undefined edges.

So to repeat the need within the agenda for evolving a list of areas and subjects to be worked on.

Finally we must evolve a plan whereby our entire nation is able to participate in the creation of the Everlasting Constitution. A process whereby like sifting for gold or slowly weaving a beautiful piece of clothing that will comfortably fit our nation's many aspects.

So now we will begin. Begin we will by looking at The Foundation.

The foundation of our Present Constitution is

The Declaration of Independence

We must begin here for its understanding has been left in a deep void as to its impact on the Constitution and its vital use in assuring that our Constitution remains secure. To the point where, the taken for fact opinion is that The Declaration isn't part of the Constitution.

So the issue which must be fiercely confronted by presenting the FACT that the Declaration of Independence is one of the Constitution's Most Important Parts. You will see how the Declaration is The Vital Tool with which any citizen may understand and confront the government as to whether or not it is keeping to its responsibility for carrying out the Constitution's laws or whether or not such officials have failed or are engaging in acts of defilement or treason.

To get right to it, it is stated point blank that The Declaration IS part of The Constitution in Constitutional Article VII.

But right before we enter the detailed explanation, I want to explain how our constitution was derailed at the very beginning. Right in the declaration it is stated that the british monarchy was and still is the enemy. The founders of the nation considered themselves loyal british subjects to the "crown". They rebelled however when they felt they were being taxed too heavily. THAT is one of the core reasons why our nation was founded. You should know that justice for and a decent life for everyone was not among the reasons our country was founded. The founders were wealthy and were primarily interested in their own security. Since they were not kings and queens they had to get into the agenda of equality and mutual fairness. The founders were not alert to the incremental injustices that started to filter into the government regarding securities for the less wealthy.

As indicated earlier The Declaration is indicated as part of the Constitution in Article VII here quoted

" The Ratification of the Convention by the Unanimous Consent of the States present the Seventeenth Day of September in the Year of our Lord one thousand seven hundred and Eighty Seven (*my comment: here I emphasize you pay attention to the key words, one capitalized, which directly indicate that The Declaration of Independence is part OF The Constitution*) of the Independence of the United States of America the Twelfth In Witness whereof We have hereunto Subscribed our Names,

Now let's step back into The Declaration itself and then move back to Article VII.

Note that the Declaration writers appeal "to the Supreme Judge of the World for the rectitude of their Intentions". They were in effect asking assistance as stated at The Declaration's beginning from "Nature's GOD". Now back to Article VII we see the theme of attempting to function under GOD'S Will. " done in convention by the Unanimous Consent of the States present in the Seventeenth Day of September in the year of our Lord".

My point can only have meaning for those who know there is a plan much larger than the plans we initiate within which we function, which is under the management of a Divine Power. The Founders of the nation knew this. For good or bad they had the ability to make something powerful happen under this belief. Although I do not wish to suggest in the least that those who do not believe in a Supreme Creator are not valid personages in the overall greater plan, with as much rights to common justice as anyone else, because I believe that the Supreme Creator's Greatness would be such that the non-believers could not exist unless they were sanctioned and supported by such a Power and not only this, but that such a BEING would have no anxieties about such nonbelievers existing and might even find it quite comical to have characters around professing with absolute belief and telling wondrous stories about how the whole show sat upon their shoulders.

Returning to The Declaration being a Vital Part to insure the Constitution's well being, we ask the question, Exactly what kind of a Tool is The Declaration ?

IT IS A MEASURING STICK WHICH MAY BE EASILY USED BY ANY CITIZEN TO JUDGE THE GOVERNMENT'S ACTIONS WHICH WILL QUICKLY INDICATE WHETHER THE CONSTITUTION IS BEING UPHELD.

Let us now look at the concerns the first American authors had when they wrote The Declaration. What abuses they were suffering, which caused them to separate from the tyrant british monarchy. I will paraphrase the concepts. These then are all the abuses listed in the Declaration.

The british tyrant refused to allow the creation of necessary healthy laws

The british tyrant had neglected to carry out necessary duties

The british tyrant's actions have exhausted the people's ability to implement government efficiency

The british tyrant interfered with the electoral process

The british tyrant manipulated the financial and tenure lives of public officials so as to hold power over them

The british tyrant created complex government structures with excessive personnel which in effect harassed and confused the lives of the people

The british tyrant kept standing armies in time of peace without the consent of the legislature

The british tyrant protected individuals of these military forces when they committed aggressions and murder against the people

The british tyrant destroyed the well being of the people's international economy

The british tyrant has oppressed the people in matters related to taxation

The british tyrant corrupted the trial system

The british tyrant imposed a format of central authoritarian rule such that it's influence trespassed upon the people's basic inalienable rights

The british tyrant has taken away the people's charter of government

The british tyrant has created legislation which overrules the people's legislation, declaring that the tyrant is the ultimate authority

The british tyrant has waged war against the people

The british tyrant has conspired to cause the people
confusion so they fight against one another

The british tyrant has brought armies who attack all ages, sexes
and conditions of the people

To this list of abuses The Declaration also states Our Basic Rights to quote

" We hold these truths to be self evident, that all Men are created equal, that they are endowed by their Creator with certain inalienable Rights, that among these are Life, Liberty and the Pursuit of Happiness. That to secure these Rights, Governments are instituted among Men, deriving their just Powers from the Consent of the Governed, that whenever any Form of Government becomes destructive to these Ends, it is the Right of the People to alter or abolish it, and to institute new Government, laying its Foundation on such Principles, and organizing its Powers in such Form, as to them shall seem most likely to effect their Safety and Happiness."

So There It IS.

Now with This Declaration any citizen can use it as a Measuring Ruler and say to the government YOU ARE BREAKING THE AGREEMENT OF THE CONSTITUTION WHICH YOU SWORE TO UPHOLD, YOU ARE COMMITTING VIOLATIONS.

So as we begin to look carefully at the federal government today with The Declaration as a measuring stick and to this apply the Constitution's rules, we see that the federal government is and has been engaging in grievous acts of fraud, treason and war crimes against
The People.

A few such most serious acts listed here

- * Attempting to overthrow the Constitution twice, via Doc. 87 which attempts to replace our Constitution with the UN Charter
- * Financing, with a 2.5 million dollar tax write-off, the creation of a new constitution the "New States of America" written up over a period of 17 years by the Institute of "Democratic Studies" which in fact is a dictatorship. In it, the senate is unelected, has life terms and has final key authority.
- * Freedom of religion is abolished
- * Freedom of press is eliminated

constitution. In combination with other facts it can be
determined that these same european forces have been,
since our country was founded working to overthrow our
nation. Therefore the federal traitors have not only
subverted the Constitution, engaged in fraud but have
conspired with enemy european powers to perpetuate covert
war against us. These same european, aristocratic and
monarchal swine thereby control the rate and value of our
money supply. The "Federal" Reserve Bank has never had an
audit. If we can't "control" meaning if we are unable to
know how our money is being spent then we cannot control
our destiny. We then are in fact slaves to the whim of
those who have the say in what the value of our money
will be. Through bribery and the glow of "prestigious"
association the federal traitors have intentionally
created our national debt by calculatngly spending us
into the indebtedness of the european bankers. Thereby we

Some of that drug money was used to hire mercenaries in the british tyrant's war against the American colonies. Can you think of a criminal organization that could compare to 10 drug wars against an entire country. Do you believe such entity would stop there or go on to capture the world's drug trade. The use of drug money against the American colonies was their first use of drugs to wage war against humanity. Read ("The World Order , our secret rulers by Eustace Mullins). The british monarchy controls the world's drug trade pouring drugs onto the world to keep humanity in a state of mental chaos, while it derives money to perpetuate its goal of world domination. The european monarchies have a long history of waging wars strictly for personal wealth. The british monarchy activated the world's first concentration camps against the Boar farmers leaving women and children to perish in slow death. The british monarchy and aristocracy waged war against South Africa to steal its gold. The beast british monarchy, aristocracy and rothschild demons have committed atrocities against humanity for centuries with no respect for anything but their vicious appetites. Note also "Independence" is Capitalized meaning that it refers to a specific thing. That thing is The Declaration of Independence. Which to the Constitutional authors had become not only the Declaration of Independence but "The Independence".

We have thus taken the first step in the investigation into our Constitution. There are three other areas that must be primarily investigated so that the National Discussion can proceed with crystal clarity for their present unclarity is a great source of the enemy's power and The People's torment.

Taxation - The Military Budget - - and a Healthier Vision of Money

We place our hand upon that crippled and demented creature called taxes. The gate moves slowly with odd unrythmic sounds as if warning us of its troublesome idiosyncrasies

Yet we push on. Beyond all the chaotic demands to Our Constitution. And as if by Divine Light, GOD'S shining touch beams through in the form of a question.

?

If, as indicated in The Declaration of Independence, The People were oppressed by UNFAIR TAXATION do you believe they would have written a Constitution that would have allowed unfair taxation? Answer. Of course not.

Second question. then where in our Constitution is there protection against unfair, corrupt or treasonous taxation?

Try to find the answer.

You may very well climb all the mountains on the planet and not come up with anyone to provide the answer even after all these years of having billions and billions of tax revenues wasted and ending up with a national debt that has no bounds.

Put in simple terms the deficit means the national government has either mismanaged or stolen The People's Money.

And yet within Our Constitution can be found four major defenses against unfair or corrupt taxation.

The First in Constitutional Article 1 Section 9

"No Money shall be drawn from the Treasury but in Consequence of Appropriations made by Law: and a regular Statement and Account of Receipts and Expenditures of all public Money shall be published from time to time,"

So here the Constitution provides The People with the Security Measure for knowing Exactly how their money, the Nation's Money is being spent.

Right away you can see that the military black budget is illegal (proof that the military budget is in effect a front for massive fraud is found in ("The Best Enemy Money Can Buy" by Antony Sutton Liberty House Press, Billings, Montana. The information proves that western industrialists have been supplying Russia with war materials. Mr. Sutton brought the proof directly to Congress. They did nothing about). Right away you can see the federal reserve bank not giving audits is illegal. Since 1914 when the federal traitors activated the "federal" reserve bank the federal gov't has existed in a state of subversion, treason and war crimes against The American People for 53 years. And it will not be corrected until We The People Correct It.

The Second Constitutional Defense against unfair taxation is Article I Section 8

"The Congress shall have the Power To lay and collect Taxes....."

This insures that there is only one control mechanism over the nation's public money. And in being so, accountability is **assured**. This does not mean the Congress has the right to force an innocent person to pay a tax. This fact is substantiated by the forth defense against unfair taxation, which will be indicated in the order of explanation. But since 1914 by virtue of the unconstitutional existence of the unconstitutional "federal" reserve bank we have an entity controlling The People's Money that has been **non accountable**.

The Third Constitutional Defense against unfair taxation is Article VI Paragraph 3

"The Senators and Representatives before mentioned, and the Members of the several State Legislatures, and **ALL** executives and judicial Officers, both of the United States and of the several States, shall be bound by Oath of Affirmation to support **THIS Constitution.**"

THIS means THIS Constitution not some other constitution or charter

No public money is to be in the hands of non government officials and all government officials are to be sworn to support The Constitution. The foreign and American owners of the "federal" reserve bank are not government officials and they are not sworn to uphold The Constitution.

Being so it amounts to an open door for massive theft of The People's Money,

The Fourth Absolute and Final Constitutional Defense against unfair taxation

Amendment XIII Section 1

"Neither slavery nor involuntary servitude, except as punishment for a crime whereof the party shall have been duly convicted, shall exist within the United States, or any place subject to their jurisdiction."

Where in The Constitution does it designate not paying taxes as a crime ? Nowhere. Point blank it is illegal to force an innocent person to work for or serve another. That includes the government. The government cannot force an innocent person to serve it. In a nation with inalienable rights not even the government may trespass those rights. When a person is forced to work or serve another they are providing another with their wealth. The other, in this situation of unjust servitude, is stealing the bound person's wealth. Where in The Constitution is the law that a person is required to pay a tax ? There is no such Constitutional law. There is nothing in the Constitution which speaks about what shall be done to a person if taxes are not paid. Whereas other activities are indicated as crimes deserving of punishment. This automatically means that within the Constitution there is no law requiring payment of tax.

The issue here is not, trying to prove that citizens should not contribute their fair share, but that there is a way for citizens to be secure against unfair, incompetent, corrupt or treasonous taxation. The authors stated this unfairness in The Declaration and have taken measures to prevent such in The Constitution.

You work to produce the wealth, of which one aspect is money. The government according to the 13th Amendment does not have the authority to force you to give it money you have worked for. It is automatically implied that your tax contribution is a matter of **YOUR willingness to pay.**

And here we have the touch of Divine Intervention, of Divine Justice and Divine Economic Stability.

If the government is being run well, The People will be MOTIVATED to pay their tax contribution. If it isn't being run well The People will not be motivated to pay a tax to an incompetent operation. There should however be Measurements, such as certain kinds of public information reports by which The People would be able to detect things going wrong long before things got to a destabilizing point. Being so, corrective measures could be taken to insure government stability.

MONEY

A Healthy Vision of Money

Fact: Throughout The Story of Life whenever the societal situation becomes such that a society's wealth becomes accumulated into the hands of just a few and the majority are without sure security that society is factually in a state of final decline. So a system, a morality, a concept of money that leads to the empowerment of few and perpetuates injustice on the majority is a societal disease. This is the situation in our world today. So primary to our rebirth is a new healthy vision of money. Without this all the appearances of newness would be just a sham of reasonable appearing lies. Happiness for a few unhappiness and frustration for many.

Since we see in Nature many variations of things why should there not also be many variations of money systems. Or energy systems, for basically money is a device for the orderly release and expression of energy.

Nature distributes abundantly to all its creations. Some use the energy well and are encouraged with more energy. Others do not use energy well and fail. But all are provided with basic energy for basic needs.

Money systems like all things have effects on people. In what way do we want our money system to affect us ? Do we want it to make us greedy ? To influence us to all be the same ? To make our lives easy and listless so we experience no challenge ? Do we want it to turn us into vicious dogs tearing at each other for each scrap of wealth ? Or should it be arranged so that it provides the motivation and opportunity for each citizen to be intelligent and to fulfill one's best productive potentials ?

Since I see nothing inspirational about decline I'll take chances on the last.

Another subtle awareness about money is that the money itself is worthless. All it is, is a medium of exchange for the really valuable goods. To give a simple example. You go to a store with money to buy food, but there's no food available. What good is the money ?

So we see that it is the tangible basic resources which are a society's most valuable goods. Those tangible valuable goods are not only raw materials but talents people have for enabling societies needed functions to occur. What good are building materials without the expertise of How To Build ?

In our constitution and government we must insure that the basic resources and basic talents are not overwhelmed but instead enhanced and well preserved.

1 and 1 leads to two. Therefore our money system should be one, to repeat, that encourages our citizens to be productive in some vital resource way.

A starting list of resources needed are FOOD, SHELTER, HEALTH, SECURITY, WISE FORESIGHT IN PLANNING, MECHANICAL ENERGY, CONSTRUCTION MATERIALS, CLOTHING, CARE OF ENVIRONMENT, GATHERING OF VITAL ONGOING INFORMATION OF ALL PHENOMENA, WITH EXPERTISE IN ALL RELATED MATTERS, SUCH AS THE WISDOM OF THE USES OF ELEMENTS.

The picture would be like, Everyone has the opportunity to receive money for basic life needs depending on the ability of the producers to produce those basic goods.

Specific situations. A person wants to start a business. The person goes to the government for start up money. The person presents a plan. The government accepts the plan and provides the money. The person pays the government back and produces wealth.

The government rejects the plan and provides the person with information so the plan can be improved.

A person lives an unproductive life. They still receive money for basic needs. For all the reasons explained but also because the fact is that society produced that unproductive person and therefore must be responsible for what has occurred. A requirement would be that once a year the person would have to report to the gov't on what they have been doing. If nothing, then they'd get the same amount. If however the person begins educating, the gov't encourages this with more money and information as to how to increase the education.

Here we see a way of money that is supportive and intelligent as well as just providing for material needs.

I ask you what's wrong with this vision of money ?

So we see that the question is no longer whether I have or I don't have money but am I being productive ? Or how can I be more productive ?

Having concluded the main difficult matters four other valuable concepts need to be understood before we glide onto the idea suggestion start off list.

The first is that all tax revenues for City, State and National be collected by the cities and placed on computer for access by the entire nation. Likewise all public expenditures be placed on computer for national citizen access. Thereby the mystery of money going to unknown places with the potential for theft or abuse is abolished.

Secondly what should be done if a citizen just refuses to pay their fair tax contribution, since to exist the organization of nation requires membership contribution for the functioning of mutually beneficial activities.

Simple procedures can be used to work the situation out.

First the citizen is asked why they are refusing to pay their tax. If the answer is dissatisfaction with certain government activities, then those activities are investigated and if found true they are corrected. The citizen is thanked, assured the matter will be taken care of in writing and thereafter pays the tax.

If the citizen's charges are untrue, the citizen is informed of such in detail. If the citizen still refuses to pay, a law is in place which cuts off their electricity, water and rights to societal security services. So in this way the citizen is reminded that they are part of a larger whole that requires giving as well as deriving group benefit.

If the citizen just doesn't have the money it means mismanagement has occurred. Government arranges a management assistance plan to get things on track with payment of due taxes included.

Third. The vital question of where should the major power of the nation be placed? Should the nation's governing be arranged so that a few people make the decisions for the entire nation? Or should the power stay close to the majority of the people who live in The Cities?

At the time of the formulation of the first constitution the majority of the people did not have the knowledge base and experience to oversee government matters. But now I believe we do. Therefore I believe the majority of governing matters should be convened and controlled by The Cities. For the cities are the organizational unit actually closest to and in touch with the needs and lives of The People.

For when you create a culture such as a national government wherein a few people run everything in plush offices and halls making decisions for millions upon millions of people who they hardly ever are directly in touch with, the people are then seen as mere piles of papers and letters, statistics and nonstop meetings and telephone calls. As things you have to pay attention to, to make sure you get a full size check.

You in effect create a cold, arrogant, uncaring, condescending, deceptive governing culture. With our present national knowledge base and computers the cities can take it on. Or answer the question Why can't they take it on?

There could be colleges of cities which work on matters for their general area. Colleges of cities who work on international trade for their particular areas.

With Power located closer to The People, The People's lives will become much more vital, interesting and secure locally and nationally.

Fourth. The only true vital national issue is national defense. We will not enter, at this time, concepts of how this could be structured except for one aspect which would be the creation of a national defense book which would describe every possible attack we could face. This book would be on a national computer access. Thereby the entire nation would have a feel for possible war occurrences and based upon the procedures of information gathering and procedures for action be readily prepared to respond.

The Military Budget

We now turn our beam upon the seemingly insurmountable problem of determining the parameters of what the military budget should be.

This problem has been difficult because of its unending justification of need due to the infinite possibilities of circumstances that could possibly occur. So how do you manage a sustaining budget for such an unknowable quantum ?

The answer is by beginning with what is solid, by paying attention to the known. What is the known ?

The known is that all money for military needs comes from The People.

therefore

as flowers cannot grow without earth and the better the earth the better the flowers, so the military cannot exist without the well being and productiveness of The People. Therefore there should be no taxation to the degree that impairs The People's well being, that impairs The People's ability to secure their basic needs and basic fulfillments and that impairs The People's ability to be productive.

If the military can't do the job with that, then get people to operate the military who can because no well being and productivity for The People, No Military.

Now as stated at the beginning we here contour a sample of new ideas to be added.

This list would be gathered from all cities and distributed nationwide for discussion and refinement.

Along with this must evolve a basic end Vision. Where do we want to get to ?

This end vision will guide us as to which new ideas do and do not apply.

Such as

the idea of no denial by a few of new technology related to improved concepts of basic resources. End Vision - we want resources which do not pollute our environment. Which are easily renewable. Which diminish the natural environment not at all or as little as possible.

So we take the End Vision and see how any new technology measures up.

Other ideas

the idea of no laws restricting activities of no harm

the idea that no economic activity may deny others their inalienable rights

the idea of the gov't closest to the daily lives of the people being the most authoritative

the idea of insuring freedom of press but also insuring that the press cannot be used by enemies to deceive or brainwash and also insuring some way by which The People do have access to vitally important information

the idea that opponents must agree to the basic rights of all in order to have membership

the idea of, the empowering the qualities of nature, being kept secure, explanation. - CHANGE is a core ingredient to survival. Cement and buildings change very little thereby accustoming people to rigidity. Nature is always involved in change dynamic and subtle. In this way being close to it people are kept in condition to deal with CHANGE. This does suggest we do not have cities but that we also always have access to abundant nature.

the idea of preventing predatory destructive development

the concept of insuring healthy cities

the parameters for dealing with beings from other galaxies or dimensions

the format for how The People and Cities unite in times of common threat

the idea of population balance in relation to our society's production capacity

the securities of employees and employers

formats for trade local, national and international

basic concepts in healthy city structural design

(comment : humanity has been locked in an aristocratic gaudy vision of architectural structure wherein exist the rulers and their servants all diminishing the fullness and power of people in general and which do not apply to life's wide variety of dynamic needs, We need a clearer, fuller vision of the beneficial dynamics of a wide range of architectural concepts. We literally live in and move through forms day in and day out. These forms emanate energies which we become accustomed to and unconsciously affect our our moods and actions and in so influence the way we interact with each other. Who hasn't been in a place where one feels sick and another where one feels great. Our living environments must be healthy, interesting, restful and exciting and the entire nation must be aware of the harmful and beneficial effects of our living environments.

the securities and rights of children

the requirements of education

the guidelines for healthy working conditions

the guidelines of our money system, which must include a deep analysis of local, national and international banking systems

the rights of groups not of the main stream

And so we see a mighty list may be developed upon which we all shall have wonderful discussions about the perfect and fine details of.

Now in conclusion we here suggest a formula to lead into an ultimate formula whereby our nation of 263,000,000 million people may sift these ideas carefully with patience and orderly methods.

1st phase local development

- (a) distribution of enemy's plan to be studied nationwide
- (b) nationwide study of our present Declaration and Constitution
- (c) citizen meetings to begin developing ideas under subject categories
- (d) gathering ideas together under subject categories then bringing them to local public government meetings for development of refinement procedures
- (f) local governments act to conclude a finalized set of concepts
- (g) local governments nationwide send finalized ideas to a main organization center which lists all the ideas into one document to be redistributed back to the cities and to The People

2nd Phase National Combining of Ideas

- (a) same processes as above
- (b) in this phase national public discussions would occur
- (c) national public discussions by experts in various fields

3rd Phase First National Vote on every single concept

- (a) there would be let's say 5 national votes
- (b) after each national vote phases 1 and 2 would be repeated with whatever actions are thought to bring greater insight

4th Final National Vote with Study Period

Substantial evidence of the covert censorship of UFO news coverage can be demonstrated by making a list of all the sightings described in Lucius Farish's indispensable UFO Newsclipping Service (Route 1 Box 220, Plumerville, AR 72127) for a time period such as from the beginning of July 1987 to the end of June 1988, including in the Credits section of this book the names and locations of all the newspapers that the articles were taken from, as well as the dates on which the articles appeared. If, after reading the following list, you will turn to the Credits section at the end of this book, you will see that nearly all of the reports, with only rare exceptions, are from small local newspapers in the areas where the incidents occurred. Hardly ever are these small local newspapers aware of UFO incidents going on elsewhere. Without the presence of Lucius Farish, regularly making an end run around the covert censorship for us, we researchers would have no way of estimating the extent and pervasiveness of the phenomena. In the following list, I have numbered the dates of the incidents, so that they correspond with the numbers given to the newspapers in the Credits section, in order to facilitate cross-referencing.

1. During the first week of July 1987, there were multiple UFO sightings with many witnesses in the vicinity of Washingtonville, Pennsylvania.

13. Sept. 14, flood of reports from Midlands, England.

21. Oct. 4, sighting at Salisbury, England.
22. Oct. 5, sighting at Staffordshire, England.
23. Oct. 6 and 8, sightings at Worthing, England.
24. Oct. 8, 16 and 18, sightings at Delmont, Pennsylvania.
25. Oct. 19, sightings at Maidstone, England.
26. Oct. 22, sighting at Bennington, New Hampshire.
27. Oct. 26, sighting at Little Fork, Minnesota.
28. Oct. 28, sighting at Staffordshire, England.
29. Nov. 2, sighting at Chichester, England.
30. Nov. 9, sighting at Edgerton, Wisconsin.
31. Nov. 10, sighting at Simi Valley, California.
32. Nov. 11, Gulf Breeze, Florida. On this date, massive multi-witness UFO manifestations began to occur in the area of Gulf Breeze, which have yielded photographic evidence of extraordinary quality. Some investigators have doubts as to the authenticity of this case, suspecting it to be an elaborate hoax, arranged with super-sophisticated equipment. However, multi-witness sightings continue to be reported as we go to press. It seems beyond coincidence that just as Foreman, Arkansas, is in the vicinity of the Red River Arsenal, so Gulf Breeze is in the vicinity of Eglin Air Force Base. The UFO manifestations at Foreman began on Jan. 19, 1988. 39. Dec. 30, sighting at Qatar, Persian Gulf, and also at Kuwait. On Feb. 7, 1988, another sighting at Qatar.

40. Jan. 1, 1988, through Jan. 27. There were 72 sightings reported from the north of England during this period.
41. Jan. 3, sighting at London, England.
42. Jan. 6, sighting at Bolton, Lancashire, England.
43. Jan. 7 and preceding week, many reports from Yorkshire, England.
44. Jan. 7 and following days, a cluster of reports from Binghamton, New York.
45. Jan. 11, sighting at Ashley, North Dakota.
46. Jan. 15, sighting at Cannon Falls, Minnesota. Also on this date, sighting at Seaford, Sussex, England. This incident is remarkable not so much for the sighting itself, which is like thousands of others already on record, but for the explanation given to account for it, and the position of the person giving the explanation. I'll first quote from an article by Sue Baird in the *Seaford Gazette* of Jan. 20, 1988, then add my comments:

A mysterious unidentified flying object was spotted silently hovering above Seaford Head just before 9 pm and reported to Seaford police.

A display of red, blue, green and white lights apparently gave way to five red lights the size of footballs traveling just above house height....

Jenny Randles, director of investigations (for the British UFO Research Association), explained that in the past two or three months, there had been similar sightings to the one seen in Seaford last week.

In fact, they turned out to be military exercises. A lot of NATO exercises, including aircraft refueling, have been taking place at night, she explained.

But often sightings turn out to be more amusing or bizarre in reality. At this time of the year, we sometimes get sightings which are geese flying south for the winter. The lights from street lamps reflect on their underbellies and make them look mysterious. One sighting turned out to be a phosphorescent owl that had eaten diseased fungi which was giving it a strange color.

The local population tends to be quite conservative, and the first witnesses to go public after a UFO chased three women in a car at terrifyingly close range on Jan. 19 were subjected to persistent harassment and ostracism, until hundreds of citizens began seeing the phenomena simultaneously and its reality became undeniable. There were also Bigfoot sightings in the region around this time.

"We've had quite a spate of these in the Midlands, about a dozen since December. Of course, there is a veil of official secrecy, but we think there may be a small squadron secretly based in Britain at RAF Alconbury." Jenny Randles seems blissfully unaware of the implausibility of testing top secret aircraft that are lit up like Christmas trees at low altitude over heavily populated areas.
