ORDERED:

That His Honor the Mayor be and hereby is authorized, in the name of and in behalf of the City of Cambridge, to lease to David P. Crowley of 9 Norton Place, Cambridge, at the rate of One Hundred (100) Dollars per year, the lease to terminate on May 11, 1926 with the privilege of renewal for a further period of three years, a parcel of City land as shown on Assessors' Block Plan #165, Lot #14 and described as follows:-

Beginning at a point in the northerly line of Murray Street ten feet distant easterly from the easterly line of Bennett Street, then running northerly by a line 10 feet distant from and parallel to the said easterly line of Bennett Street 22 feet, then turning and running easterly about 13.5 feet (said line if produced being at right angles to Bennett Street), then turning and running southerly about 22.5 feet to Murray Street, then turning and running westerly by said Murray Street 13.5 feet to the point of beginning. Containing 300 square feet more or less.
