ORDERED:

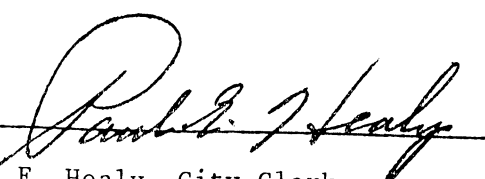

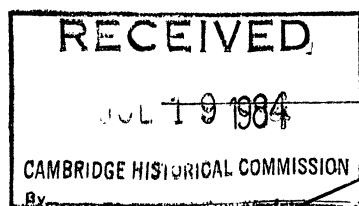
