To The Honorable, The City Council:

I am hereby requesting the appropriation of \$149,980.00 in the Grant Fund of the Department of Human Services Salaries and Wages Account (\$81,796.00), Other Ordinary Maintenance Account (\$64,034.00) and the Travel and Training Account (\$4,150.00) from the Massachusetts Department of Education. In 1994, the Kids' Council received a two-year grant from the Massachusetts Department of Education for the Centers for Families project. This project develops school-linked, neighborhood-based programs which provide broad based support services to families. A pilot project was established in the North Cambridge neighborhood. This appropriation provides for the second year of grant funding for the continuation of the project. These funds will be used to staff the project, purchase necessary equipment and services and provide for occupancy expenses.
