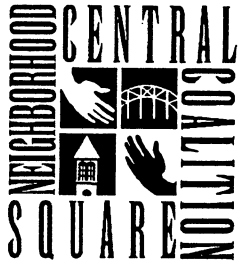

Dear Mr. Tobin:

I am writing to request reconsideration of your decision to cease accepting utility bill payments at the 600 Massachusetts Avenue Purity Supreme, effective March 31, 1996, as stated in Missey Greely's letter dated February 16, 1996.

The Central Square community was most grateful when you decided last December, upon our request, to postpone this action until March 31. We were hopeful that your "aggressive attempts to sell the store" according to Ms. Greely, would have resulted in a new owner by now who would continue the service, recognizing its importance to his patrons.

In asking you to continue this service until a sale is completed, we hope you will consider the following points:


1. Approximately 190 utility bills are accepted daily at the customer service window. The vast majority of our neighbors, after paying their utility bills, go on to shop in your store. We believe that discontinuing this service would decrease revenue for your store. Decreasing revenue as you are attempting to sell the store does not make sense to us.

2. We understand and accept Stop & Shop's decision to sell the store. We are asking you to understand the importance of these consumer services to the diverse population which has supported the store for many years. Please leave these services in place in order that we may have the most favorable opportunity to prevail upon the new owners as to the important role the customer service window plays in our community.

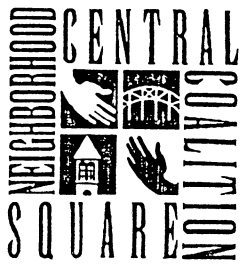
3. The CSNC and the City of Cambridge are working on your behalf in attempting to find buyers for the store. Please do not diminish the store as we are attempting to help you sell it.
