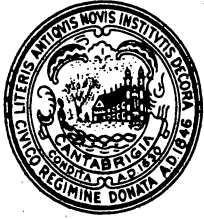
The Department of Administration has the sum of \$18,000 in its A-1 account which may be transferred as the City Manager sees fit.


