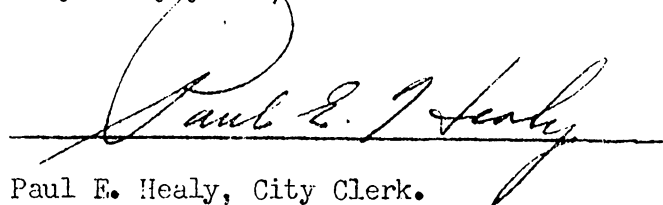
Dear Neighborhood Representative:

The undersigned respectfully pray that a driveway for
