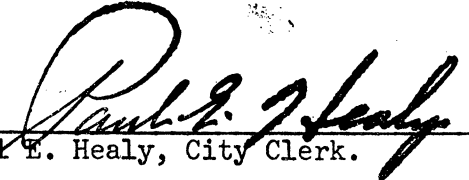

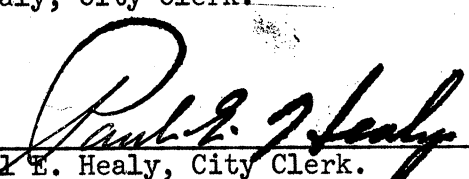

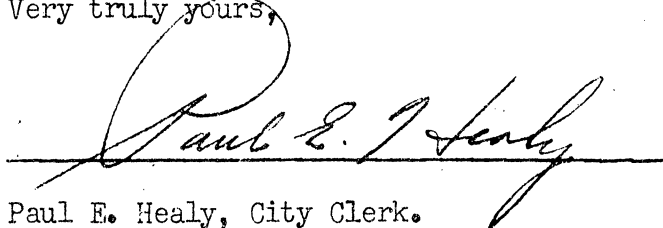
Ilene S. Miller requesting a driveway at the premises numbered

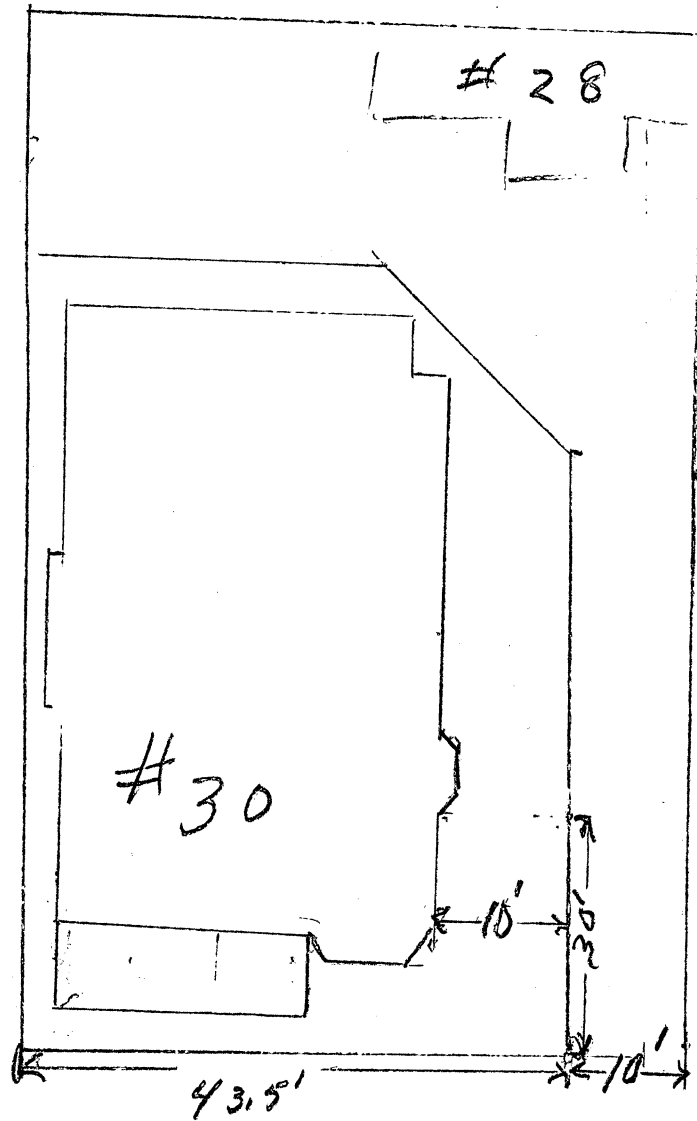

SKETCH PROPOSED DRIVEWAY AT #30 DOVER ST



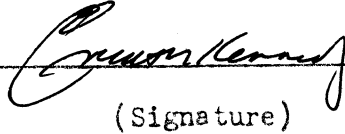
