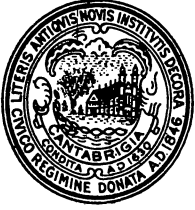

I hereby request an appropriation in the amount of \$81.53 to reimburse Ralph Freda, employee of the Public Works Department, for damages in this amount.

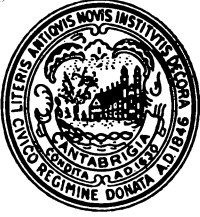
The Law Department, under the provisions of General Laws, Chapter 41, Section 100-A, defended an action against Ralph Freda, in which there was a judgment of \$81.53.
