At the School Department Budget hearing held on May 27, 2003 Councillor Toomey raised several questions concerning Special Ed Tuition Out. These questions were conveyed to you in a memo from this office dated June 4, 2003.

On June 9, 2003 Councillor Toomey exercised his charter right on an appropriation of \$504,198 to cover the cost of additional Special Ed Outside Tuitions. Subsequently you forwarded to Councillor Toomey a report, under separate cover, on this matter.

On June 16, 2003 Councillor Toomey moved the adoption of the appropriation but requested that the report sent to him be referred back to the City Manager for clarification.
