

GENERAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That the ROYAL GLOBE INSURANCE COMPANY

virtue of the Laws of the State of ILLINOIS, Corporation organized and existing by and appoint does hereby nominate, constitute

HUGH M. CHAPIN or GEORGE M. DALEY or DIANNE M. MORRISSEY

of CAMBRIDGE, in the state of MASSACHUSETTS its true and lawful attorney(s)-in-fact to make, execute, attest, seal and deliver for and on its behalf, as surety, and as its act and deed, where required, any and all bonds, undertaking, recognizances and written obligations in the nature thereof, the penal sum of no one of which is in any event to exceed FIFTY THOUSAND (\$ 50,000.) Dollars.

Such bonds and undertakings, when duly executed by the aforesaid Attorney(s)-in-fact shall be binding upon the said Company as fully and to the same extent as if such bonds and undertakings were signed by the President and Secretary of the Company and sealed with its corporate seal.

This Power of Attorney is granted and is signed by facsimile under and by the authority of the following Resolution adopted by the Executive Committee of the Board of Directors of the Company on the 5th day of September 1968:

"RESOLVED, That the President, or any Vice President of the Company or any person designated by any one of them is hereby authorized to execute Powers of Attorney qualifying the attorney named in the given Power of Attorney to execute in behalf of the Company, bonds, undertakings and all contracts of suretyship, and that any Secretary or any Assistant Secretary of the Company be, and that each or any of them hereby is authorized to attest the execution of any such Power of Attorney, and to attach thereto the Seal of the Company.

FURTHER RESOLVED, That the signature of such officers and the Seal of the Company may be affixed to any such Power of Attorney or to any certificate relating thereto by facsimile, and any such Power of Attorney or certificate bearing such facsimile signatures or facsimile seal shall be thereafter valid and binding upon the Company with respect to any bond, undertaking or contract of suretyship to which it is attached."

# Know all Men by these Presents,

THAT I, **Lawrence E. Tinsley**

To which payment, well and truly to be made, we firmly bind ourselves, our heirs, executors, administrators, successors and assigns by these presents. Witness our hand and seals. Dated the **25th** day of **January** in the year of our Lord one thousand nine hundred and **Seventy-seven**.

THE CONDITION OF THIS OBLIGATION IS SUCH,

That the aforesaid

**Lawrence E. Tinsley**

having been appointed by the City Manager of the City of Cambridge one of the Constables within the said City, for the term ending <sup>three</sup> ~~four~~ year from the first Monday in January, 19 **77**, and until another be appointed in his place, now if said **Lawrence E. Tinsley** shall faithfully exercise all the powers and perform all the duties entrusted to and imposed upon him by the laws of the Commonwealth and the ordinances of the City of Cambridge; shall carefully intend the preservation of the peace, the discovery and prevention of all attempts against the same; shall duly execute all warrants which shall be sent unto him from lawful authority, and faithfully attend to all such directions in the laws and orders of Court, as are or shall be committed to his care; shall comply with the orders and directions of the City Manager and Council, which shall be passed from time to time for the regulation of the Constables; shall faithfully and with what speed he can, collect and levy all such fines, distresses, rates, assessments, and sums of money for which he shall have sufficient warrants according to law, rendering an account thereof, and paying the same according to the direction in his warrant; and also, if he shall faithfully perform all the duties of a Constable in the service of all civil processes which may be committed to him, then this obligation shall be void, otherwise it shall remain in full force and effect.
