ORDERED:

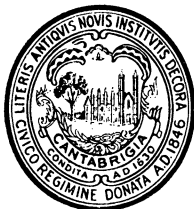

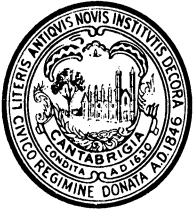
