AN ORDINANCE

IN AMENDMENT OF AN ORDINANCE IN RELATION TO FIRE DEPARTMENT.

Be it ordained by the City Council of the City of Cambridge as follows:—

- 1 Section 8 of Chapter 16 of the Revised Ordinances is hereby amended
- 2 in the second line thereof by inserting after the word "Cambridge" the
- 3 words "or whose daily occupation is carried on outside of the city limits."
- 4 Also in the same line by inserting after the word "appointed," the words
- 5 "or continue."

This ordinance shall take effect on the first day of December, 1888.

As amended the section will stand as follows:—

SECTION 8.—No person who is not a legal voter in the City of Cambridge, or whose daily occupation is carried on outside of the city limits, shall be appointed or continue an officer or member of the fire department.
