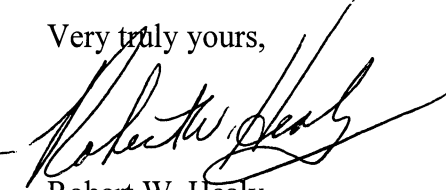
The total needed for completion of the project, including the project coordinator's salary, breaks down as follows:
