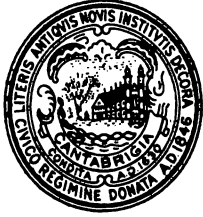



To the Honorable, the City Council:

It is respectfully requested that favorable consideration be given to an additional appropriation to the General Services - Other Ordinary Maintenance account in the amount of \$10,000, said sum to be made available by transfer from the Reserve Fund - Extraordinary Expenditures. This transfer is necessitated due to the thirty percent increase in postage rates in December of this past year.
