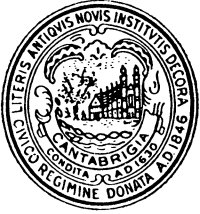

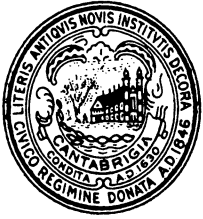
It is requested that a supplementary appropriation in the amount of \$20,000.00 be appropriated to the hospital department, F-Lump Settlement, re: Paul Accarino.


