Dear Mayor Duehay:

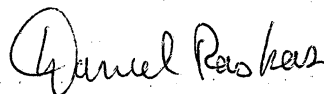
On December 31, 1998, Globetrotters, Inc. ("Globetrotters") will permanently close its Cambridge, Massachusetts facility, which is located at 139 Main Street, Cambridge, Massachusetts, 02142. Our review of the relevant law indicates that the provisions of the Worker Adjustment and Retraining Notification Act of 1988 ("Act") do not apply to this plant closure. Nevertheless, because the Act encourages voluntary compliance with its notice provisions, this letter serves as notice to your office of the facility's permanent closure and related layoffs.

The Act encourages us to list the job titles or positions of all employees affected by the facility's closure. Such a list is attached hereto. No "bumping" rights exist and none of the affected employees is represented by a labor union.

Globetrotters has already provided notice of the facility's closure and expected layoffs to its Cambridge employees.
